**RESOLUTION 01-01-06**

**A RESOLUTION AMENDING RESOLUTION NUMBER 07-12-04 DEDUCT METER FEES, PRACTICES AND PROCEDURES ADDING A NEW SECTION REQUIRING INSPECTION AND A FINAL READING WHENEVER PROPERTY OWNERSHIP CHANGES**

WHEREAS, the Peters Township Sanitary Authority, a municipal corporation organized under the Municipal Authorities Act of 1945, for the purpose of providing a sanitary sewer collection, conveyance, and treatment facilities, and for providing the staffing and financing to operate said facilities:

WHEREAS, The Peters Township Sanitary Authority desires to require an inspection and final read for deduct meters upon change in ownership.

NOW, THEREFORE, BE IT RESOLVED, that The Peters Township Sanitary Authority hereby resolves to adopt the following:

Prior to sale of any property, a final deduct meter read must be obtained from the actual deduct meter. The current property will receive their deduct credit; if any, in their final bill and then deduct meter service will be suspended.

The new property owner will have to establish the deduct meter service by completing an application and having an inspection performed by the Authority staff.

The applicable fees associated with the implementation of this policy shall be set forth in Section C of Schedule A, known as "The Schedule of Rates and Charges". Schedule A may be revised by proper Resolution of Board.


The effective date of fee schedule and procedures hereby resolved shall be January 10, 2006
