RESOLUTION NO. 08-12-04

**AMENDING THE STANDARD PROCEDURES FOR CUSTOMERS WISHING TO SECURE A PERMIT
FOR SANITARY SEWER CONNECTION.**

WHEREAS, the Peters Township Sanitary Authority, a municipal corporation organized under the Municipal Authorities Act of 1945, for the purpose of providing a sanitary sewer collection, conveyance, and treatment facilities, and for providing the staffing and financing to operate said facilities.

WHEREAS, the Peters Township Sanitary Authority has from time to time realized that certain properties which request sanitary service are susceptible to potential sewage back-ups resulting from circumstances beyond our reasonable control due to the rim elevation of the lowest fixture served lower than the rim elevation of the upstream manhole located on the sanitary line which serves said property, and,

WHEREAS, the need exists to protect said property from potential back-up and to set forth the applicable fees.

NOW, THEREFORE, BE IT RESOLVED, that The Peters Township Sanitary Authority hereby resolves to adopt the following to implement the following procedural changes for potential customers' wishing to purchase a Permit For Sanitary Sewer Connection:

When it is determined, through review by the Authority Engineer and/or its Management, that a property will be susceptible to sewage back-up, a "Backwater Valve Agreement" (as attached), which sets forth certain terms, conditions and responsibilities, must be signed by the property owner/owners and same notarized. The Agreement must be completed and returned to the Authority prior to the issuance of the Permit For Sanitary Sewer Connection and shall become an integral part of the Permit.

The applicable fees associated with properly recording the agreement with Washington County Recorder of Deeds is set forth in Section E of the Schedule A, known as "The Schedule of Rates and Charges". Schedule A may be revised by proper Resolution of Board. Such fee shall be paid at the time the agreement is completed and return to the Authority and prior to Permit being issued. The said fee will be payable to "Peters Township Sanitary Authority" and deposited into the Authority's Operating Fund.


Failure to agree to the terms and conditions set forth in the Agreement, will result in the refusal by the Authority to issue a Permit for said premise.

All other resolutions and parts thereof which are in conflict with this resolution are hereby repealed to the extent of such conflict.


