MAY 9, 2018

Mr. Hanley reported the status of the Hidden Brook Sanitary Sewer emergency repair. The Geotechnical report is in draft form and will be submitted to staff for review. The preparations for the Part II permit application have commenced.

Mr. Hanley reported the status of the DC WPCP Interceptor Improvements Project. HRG has responded to comment letters from the PaDEP on the NPDES permit application. The Water Quality Permit Part II permit application is anticipated to be submitted by May 14, 2018. Mr. Hanley has had contact with the design engineer working on the McDowell Road Bridge replacement. Mr. Hanley will continue coordination efforts regarding securing a future easement.

Mr. Hanley reported the status of the Rutledge Drive area sewer project. The draft bidding documents have been submitted to Management for review. It is expected to advertise for bid in June for a bid opening in July.
