- **Activate a deactivated meter - Upon submittal of the application, the Homeowner must contact this office to schedule an inspection.**

**NO CREDIT WILL BE ISSUED UNTIL THE METER IS INSPECTED AND SEALED BY PETERS TOWNSHIP SANITARY AUTHORITY PERSONNEL.**

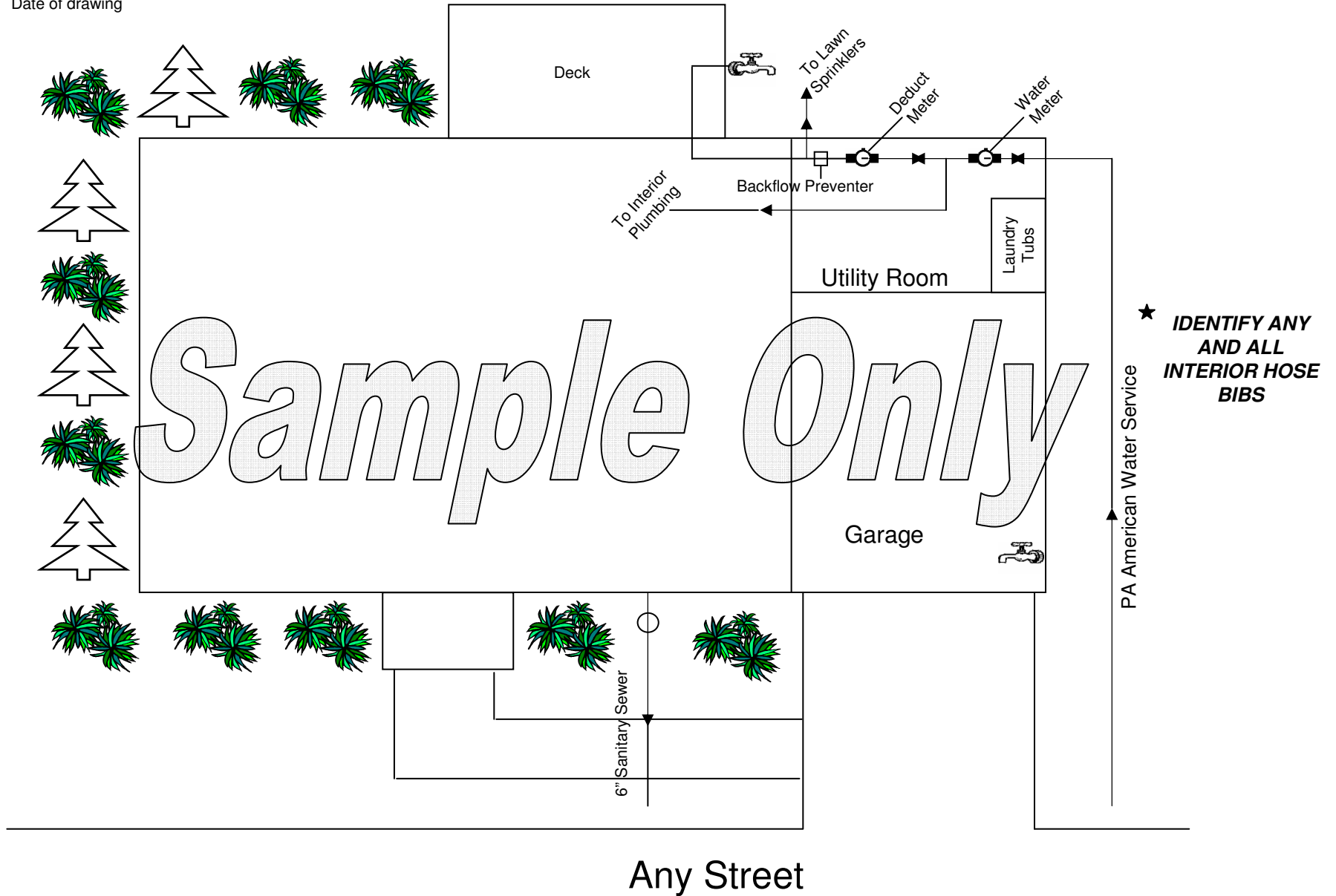
